

“OFFICIAL RULES”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes is sponsored by Wente Vineyards, (the "Sponsor").

1. **ELIGIBILITY.** Sweepstakes participation is open only to legal residents of the United States and the District of Columbia (except Utah and where prohibited or restricted by law), who are 21 years of age or older at the time of entry. The “Ultimate Wine Country Experience Sweepstakes” (“Sweepstakes”) begins 12:01 AM Pacific Standard Time (“PST”) on February 26, 2018 and ends 11:59PM PST on June 30, 2018 (“Entry Period”). Electronic entries must be received by 11:59PM PST on June 30, 2018. All entries become the property of Sponsor and will not be acknowledged or returned.

The following individuals are not eligible: employees, contractors, directors and officers of Wente Vineyards and each of its respective parent, affiliates, subsidiaries and web-design, advertising and promotion agencies, fulfillment, judging or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, "Parties"); employees of licensed alcoholic beverage manufacturers, distributors and retailers of alcoholic beverages, as well as state or local alcohol beverage agencies and their employees, are not eligible; any individuals (including but not limited to employees, consultants, independent contractors, and interns) who, within the past six (6) months, performed services for Sponsor, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying the prize, and/or their respective parent, affiliates, subsidiaries, and successor companies; and immediate family and household members of such individuals, are not eligible to enter or win. 2. **TO ENTER.**

ONLINE

Your participation on Facebook must comply with the Terms and Conditions posted on www.Facebook.com/terms. You are providing your entry information to Sponsor and not to Facebook.
